We commenced our RoHs project in June 2005 and worked with our suppliers to jointly develop RoHs products, particularly regarding acceptable temperature capabilities for SMT Reflow and Wave Solder applications. Our Stores were purged of all Non RoHS stock prior to July 2006.

Where required we are still able to source non-compliant parts, but these must be specifically requested in writing by the customer and are purchased on a back-to-back basis, with no stock above the customer's requirement being held at Westfield.

Some Military application products are only available as Non RoHs and these will be notified to you before acceptance of any order, as such items are specifically manufactured to order, they would have MOQ's applied and are supplied as Non Cancellable / Non Returnable.

All Westfield Invoices State: All Items are RoHs unless otherwise stated.

The composition substances of the parts supplied by Westfield are part specific. If you are concerned about the composition of a specific part or parts, please contact us with the details and we will endeavour to verify the part composition for you with the relevant manufacturer.

Westfield is ISO9001:2008 certified by NQA and has 100% traceability of all items supplied since 1995.
